Policy statement

Within the context of working for and collaborating with Bonn & Mees, the management strives to realize safe, efficient and environmentally responsible business operations.

Given the economic possibilities of Bonn & Mees Floating Sheerlegs B.V., the policy of implementing the policy was based on the principle of the highest possible QHSE level. Decentralization of the QHSE system was chosen. The management is convinced that by safeguarding responsibilities for the QHSE system at all levels and in all departments, QHSE thinking, policy and system lead to a culture in which thinking in improvement processes contributes to the objectives of the organization, employees and relations.

Bonn & Mees Floating Sheerlegs B.V. is aware of the specific safety and environmental risks involved in carrying out its core activities. This means that preventive measures have been taken and will be taken in the future to promote safety and minimize environmental impact. Attempts will be made to prevent accidents and illness from occurring. The preventive activities include the training and instruction of all employees, the maintenance and inspection of the floating sheerlegs, tugs, machines and tools, registering and discussing dangers, dangerous situations, near accidents and accidents. We give priority to reducing safety risks over reducing other risks.

It is our firm belief that we can guarantee the best service to our customers and suppliers through QHSE care (both guaranteeing and increasing efficiency) and to minimize the risks associated with performing our work. The mindset of our employees is extremely important here; Thinking and acting from a QHSE point of view must be in the blood of our employees. Information, training and addressing each other are essential for this. We continue to work on improving our quality, working conditions and environmental care and performance.

This statement is issued by Bonn & Mees Floating sheerlegs B.V. actively communicated to the employees and is freely accessible in our maintenance system and hard copy manual. This statement has also been included on our website, making it available to interested parties.

We try to implement this by introducing changes in working methods or processes, where necessary, in consultation with the employees. This policy is supported by all employees within our company.
